

#### CEPT/Reciprocal Amateur Radio application costs

- Fixed local bank charges for incoming foreign currency wire transfer is Afl. 7.50 (USD 4.25) and is incurred by the sender/originator of the funds transferred.
- Processing fee is Afl. 50,00 (USD. 28.19) according to article 1, letter C of the national decree "Retributies en Legesbesluit Directie Telecommunicatiezaken 2007" (AB 2007 no.119).
- Inspection fee (only applicable when travelling with HAM radio equipment, handheld HAM radio equipment is exempted from inspection) is Afl. 50,00 (USD. 28.19) according to article 1, letter H, number 9 of the national decree "Retributies en Legesbesluit Directie Telecommunicatiezaken 2007" (AB 2007 no.119).
- Special call sign fee (if requested) is Afl. 50,00 (USD. 28.19) according to article 3, letter C of the national decree <u>"Retributies en Legesbesluit Directie Telecommunicatiezaken 2007" (AB 2007 no.119).</u>
- The exchange rate from USD. to AWG. is fixed: USD. 1.00 = AWG. 1.78

Following a table with the application costs in all possible scenarios when applying for a permission to operate an amateur radio station (during a short visit up to 90 days) in accordance with CEPT T/R 61-01 recommendation or a reciprocal amateur agreements between Aruba and country of applicant.

Take notice that the OUR (SWIFT standard field 71A) expense regulation method should be used to avert delays in the application process due to (most commonly cause) insufficient funds transferred. To avoid shortage in any circumstance (deduction of international transfer charges/intermediary bank charges, exchange fluctuations when transfer is originated in another foreign currency than USD. etc.) explicitly instruct your financial institution that final beneficiary must receive the amount of incurred application costs (all transfer costs are incurred by sender/originator of transfer).
